



It calculated all necessary structural reinforcements, performed towage and lifting calculations per DNV regulations, and applied advanced design methods. This enabled safe and efficient project execution, ensuring the ship's successful recovery and repair.

Recently, TRESIOS announced a strategic repositioning focused on two core pillars: subsea construction services and marine services. This move clarifies the services provided and signals its shift towards becoming a full-service contractor.
